I will explore the beliefs, values, training, scope of practice, and treatment procedures of both religious leaders offering counseling to practitioners and counselors/psychologists that also provide direct services to clients.

I strongly believe that the inclusion of the client's spiritual and religious faith can be a source of hope and meaning and has the potential to create a therapeutic environment that recognizes and honors the client's values and available resources to promote healing, resilience, and post-traumatic growth.
